

Simplifying clients' prospectus experience for AXA World Funds

AXA IM's prospectus redrafting effort will reduce the AXA World Funds prospectus length by two-thirds

In an age when investors are confronted with numerous documents when making their investment decisions, AXA IM is making the AXA WF prospectus more accessible to clients everywhere.

What's new?

AXA IM issued a revised AXA World Funds prospectus in a more client-friendly format, to present fund information in a more concise, clear and accessible manner. Whereas the revised prospectus **does not imply any changes to the funds or the fund characteristics**, it is shorter, clearer, written in "plain language," and no longer includes duplicate information. It is therefore only a change in format and presentation.

What does this mean for me?

- **Better readability:** the new AXA WF prospectus has reduced the number of pages by approximately two-thirds, from over 550 pages to under 180 pages today. It is now easier to find information concerning the funds of interest to you.
- **Clearer wording:** the new AXA WF prospectus incorporates "plain language", making it more direct and easier to understand.
- **Enhanced formatting:** fund specific information is limited to one or two pages and more information is captured in table format.

What's next?

Having received approval from the Luxembourg regulator, the new AXA WF prospectus is available in English where the prospectus is normally available, including AXA IM websites and external databases such as Morningstar, Fundinfo, etc.

Translations of the English version of the prospectus will be published as soon as available.

Some share class level detail is no longer available in the new AXA WF prospectus such as the ISIN codes, however these remain visible on AXA IM websites, external databases and the published KIIDs (in countries where the shareclass in question is authorized for distribution).
